We are located at 849 Point Brown Avenue NW, the main street in downtown Ocean Shores, Washington.

We are accepting applications from artists in 2-D and 3-D works of photography and art: drawing, painting, mixed media, glass work, sculpture, wood and metal.

Member artists enjoy the camaraderie and support of fellow members and actively participate in The Gallery's operation.

If you are considering applying for membership with The Gallery of Ocean Shores, you should be actively working in your art and have experience exhibiting and selling your artwork. It is important that you have a consistent body of work and a sufficient inventory of completed work to rotate art in The Gallery.

- Work two days a month in the Gallery, open and close Gallery and conduct retail transactions.
- Follow all Gallery and Guild policies and procedures.
- Rotate art in The Gallery - original work every 60 days and prints, cards, etc., at least semiannually.

## Jury Process for Gallery Membership

If the Gallery Committee notifies you, they would like to meet with you and evaluate your original artwork, you will be invited to attend the monthly Gallery Artist Meeting held at 5:30 p.m. on the Third Saturday of the month in the Guild Workshop at 849 Point Brown Avenue NW in Ocean Shores, Washington.

This meeting is an opportunity for you to introduce yourself and your artwork to The Gallery artists and for you to ask questions of the artists and learn more about The Gallery and North Beach Artists Guild.

Please bring:

- Five original artworks. Include different mediums you would like to exhibit, if applicable. Bring other printed materials – prints, cards, etc. you would also like to market.
- All artwork, prints, cards, etc. should be Gallery ready.
- After the meeting, you will take your artwork with you.

You will be notified as soon as possible if your application has been approved for membership in The Gallery of Ocean Shores.

If approved to become a member of The Gallery of Ocean Shores, you will sign an Artist's Agreement that includes Gallery policies, procedures and Gallery Artist Responsibilities.

- Artists will provide a current Washington State Business UBI (Unified Business Identifier) number and a federal W-9 taxpayer identification form. Artists are responsible for personal Washington State business and occupation taxes, federal income taxes, and other areas of personal financial liability.

The Artist's Agreement also asks artists to acknowledge the following:

1. North Beach Artists Guild collects and remits sales tax to Washington State and the City of Ocean Shores. The Guild is not responsible to pay other business or personal taxes for artists.
2. Neither North Beach Artist Guild nor The Gallery of Ocean Shores carries damage or loss insurance for artist's work, and neither is liable for any damage to or loss of artist's work.
